Born 1963. He graduated in Political Sciences from Sapienza University of Rome and received an honorary master's degree in Chemical Engineering from Politecnico of Milan. He is the Chairman and majority shareholder of Maire Tecnimont Group, one of the main engineering contractors in oil & gas and petrochemicals in the world and now active Italian player in energy transition technologies.

Fabrizio Di Amato was named 'Cavaliere del Lavoro' in May 2016, an honorary Order of Merit bestowed by the President of the Italian Republic, and recently Member of the Board of Directors of Central Group. He is an active supporter of a systemic approach, where public and private are cooperating, in order to define the industrial policies for the development of the Country.

He began his career as an entrepreneur at the age of 19 by setting up his first company with three employees. He built up the Maire Tecnimont Group over three decades through a process of internal growth and acquisitions.

Today, the Group operates through 50 companies in 45 countries, having a 2020 turnover of more than 2.6 billion euro in the COVID year.

The highlights of the Group creation include:

2004 - Acquisition of Fiat Engineering, a civil infrastructure and energy company, from the Fiat group, allowing the Group to become a general contractor and start to operate abroad.

2005 - Acquisition of Tecnimont from energy company Edison. The Group expands its activities in the petrochemical and Oil&Gas sectors. It establishes itself as an international leader with a network of companies and branches all over the world.

2007 - Listing on the Milan Stock Exchange, followed by the acquisition of the Indian subsidiary Tecnimont Private Limited based in Mumbai, which becomes the Group's second engineering hub after Milan.

2009/2010 - Maire Tecnimont Group's growth continues with the acquisitions of the Dutch company Stamicarbon, world leader in urea technology, and the Italian company Kinetics Technology, process engineering contractor of excellence in the Oil&Gas sector, thereby enriching its technological expertise.

2018 - NextChem is founded, a company dedicated to green chemistry and energy transition technologies.

Fabrizio Di Amato plays an active role in the Italian engineering industry: from 2006 to 2010 he was President of Animp (Italian Association of Industrial Plant Engineering). In 2008 he promoted the concept of a unique representative body for the whole engineering

and contracting industry through Federprogetti (the Federation of Italian plant industries), of which he was founder and served as President until May 2015. He is member of General Council of Unindustria and Assolombarda. Finally, he is member of the Executive Committee of the Association of Joint Stock Companies incorporated in Italy (Assonime).

As an advocate of an integrated approach between industry and academia, Di Amato has always been a supporter of university cooperation programs between the Group and some of the most prestigious Italian technical and humanistic institutions of higher learning.

Father of five children, he is passionate about boating, skiing, and art. An optimist by nature, he follows politics with passion and civic commitment.
